**OFFICIAL CALL  
SPOTSYLVANIA COUNTY REPUBLICAN COMMITTEE  
2023 MASS MEETING**

As Chairman of the Spotsylvania County Republican Committee (“SCRC”), and pursuant to the Plan of Organization of the Republican Party of Virginia and as recommended and directed by the SCRC, I, Brett Pritchett, do hereby issue this call for a Mass Meeting:

**WHEN AND WHERE**

1. To be held at the Marshall Center Auditorium, 8800 Courthouse Road, Spotsylvania, VA 22553 or such alternate location as the Chairman may direct as necessary, at 10:00 AM local time on June 3rd, 2023. Registration will open no later than 8:45 AM and will close at 10:00 AM, or until registration of all those persons in line to register at 10:00 AM is complete.

**REASON FOR MASS MEETING**

2. For the purpose of:
  - a. Nominating a candidate for Sheriff;
  - b. Nominating a candidate for Clerk of the Court;
  - c. Nominating a candidate for Commonwealth Attorney;
  - d. Nominating a candidate for Supervisor in the Courtland District
  - e. Nominating a candidate for Supervisor in the Chancellor District
  - f. Nominating a candidate for Supervisor in the Livingston District
  - g. Nominating a candidate for Supervisor in the Salem District
  - h. Nominating a candidate for Treasurer
  - i. Nominating a candidate for Commissioner of Revenue
  - j. For the transaction of such other business as may properly come before the Mass Meeting.
  - k. Candidates must have a majority (50% +1) vote or greater in order to be elected.

**QUALIFICATIONS FOR PARTICIPATION**

3. All legal and qualified voters of Spotsylvania County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting orally and in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years OR made a campaign donation to a party other than the Republican Party in the last five years. A single exception to the above shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. A voter that utilizes the foregoing exception, and

thereafter participates in the nomination process of a Party other than the Republican Party, shall not have the benefit of the exception as identified in this paragraph thereafter.

In order to participate as a voting member of the Mass Meeting, an individual must be registered to vote no later than the pre-filing deadline established by the Official Committee. This pre-file deadline has been established as Saturday, May 20, 2023. Any person who has made application for registration on or before the pre-file date and meets all other requirements herein, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

#### **PRE-FILING REQUIREMENTS**

4. Candidates for election to offices elected at the Mass Meeting shall file a written statement, using the appropriate form attached to this Call, by mail, scanned email attachment, or in person, to Jane Laughman, at 9 Teton Drive, Fredericksburg, VA 22408 or email at [info@spotsyrepublikans.com](mailto:info@spotsyrepublikans.com), which must be received not later than 8:00 PM local time on May 20, 2023 for any elected office sought together with any mandatory or voluntary filing fee.
5. No nominations for office will be accepted from the floor of the Mass Meeting.

#### **FILING FEES**

6. Filing fees are as follows:
  - a. \$100 mandatory filing fee for elected offices sought;
  - b. There will be no fee for participation in the mass meeting.

#### **RESOLUTIONS**

7. All Resolutions proposed for consideration at this Mass Meeting must be presented to Brett Pritchett, Chairman, by email ([info@spotsyrepublikans.com](mailto:info@spotsyrepublikans.com)) no later than 5:00 p.m., May 20th, 2023

8. The SCRC Chairman shall appoint the Chairmen and members of the following Mass Meeting committees:
