I hereby declare that I am qualified to seek election and/or participate at the March 2, 2024 Spotsylvania County Republican Mass Meeting and affirm that (Please check ALL that apply):

- I am a registered voter in Spotsylvania County;
- I am in accord with the principles of the Republican Party;
- I intend to support the Republican nominees in the November 5, 2024 general election;
- I understand that if I publicly support a candidate in opposition to a Republican nominee subsequent to a statement of support that I shall not be qualified to participate in party actions for a period of four years; and
- I have not participated in the nominating process of another party in the last five years;
- OR I have participated in the nominating process of another party in the last five years, but I renounce affiliation with any party other than the Republican Party, intend to support the nominees of the Republican Party in the future and understand that the Spotsylvania County Republican Committee shall provide a copy of this signed renunciation statement to the Republican Party of Virginia, to be maintained for a period of 5 years.

NOTE: Article VII, Section C of the Republican Party of Virginia's Plan of Organization states the following about membership on a county committee:

A member of an Official Committee is held to a higher standard of support for nominees of the Republican Party than an individual who merely participates in a mass meeting, party canvass, convention or primary. Therefore, a member of an Official Committee is deemed to have resigned his Committee position if he (a) makes a reportable contribution to and/or (b) allows his name to be publicly used by and/or (c) makes a written or other public statement in support of a candidate in opposition to a Republican nominee in a Virginia General or Special Election.

By signing this form, I certify that I am a registered voter in Spotsylvania County, have read and understand the requirements above and that I intend to support all nominees of the Republican Party during this election (for convention delegates) and/or during my two year term as a member of the Spotsylvania County Republican Committee. Also, I have read and understand other requirements herein including, but not limited to Article 1 of the Plan of Organization which states in part:

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.
